

The Square at Woodville West Meet Greet & Eat Competition Terms and Conditions

The Promoter is the Urban Renewal Authority, trading as Renewal SA, GPO Box 698 Adelaide SA 5001, ABN 86 832 349 (“Promoter”).

ELIGIBILITY:

- 1) By entering into and participating in this competition, each entrant fully and unconditionally agrees to and accepts these Terms and Conditions and is deemed to have read and understood these Terms and Conditions.
- 2) To be eligible for this competition, an individual must be a legal resident of Australia, residing in South Australia, Queensland, New South Wales, Northern Territory, Western Australia or Victoria.
- 3) Employees (and their immediate families) of the Promoter, contractors of the Promoter, related bodies corporate and companies or agencies associated with this competition are ineligible to win this competition.
- 4) Only one entry per person is permitted.
- 5) Entrants under the age of eighteen (18) years of age must have parental/guardian approval prior to submitting their entry.

- 16) All times are in Australian Central Daylight Time.

HOW TO ENTER:

- 18) Fill in a competition entry form available on the day.

LIMITATION TO ENTRY:
